#### **PAREA: Practical Applications of Real Estate Appraisal**

Providing an alternative to the traditional supervisor and trainee model for residential appraisers.

Become a mentor to participants enrolled in the Appraisal Institute Practical Applications of Real Estate Appraisal (AI PAREA) on a contract basis. AI PAREA is an online program covering appraisal theory and methodology in real-world simulations, with mentoring from expert appraisers.

Mentors raise the problem-solving abilities of participants by increasing their confidence in their acquired skills. Mentors will not only advise and guide participants through the AI PAREA experience, but will also be catalysts for enriching participants' career development.

Potential mentors should be accessible, as availability is the hallmark of a great mentor. Mentors should be authentic and genuinely interested in developing the next generation of appraisers. They are called to be objective, recognizing that real growth comes from receiving honest feedback. Essential to the long-term development of participants is that mentors will challenge participants and provide help and praise. Mentors to the AI PAREA program must also be dedicated to continual learning. Mentors need to be open to new ideas, and recognize that different scenarios may require creative solutions that may be unfamiliar or atypical for their own markets. Finally, mentors should possess strong core values. It is expected that mentors will be admired and respected for their experiences, how they carry themselves, and how they treat others. #### **President's Remarks**

Happy Spring Great Lakes Chapter!

I hope this newsletter finds you and yours doing well. Since our last newsletter and the 1<sup>st</sup> Quarter Chapter meeting, the trees have bloomed and the grass is greening up — always a welcome change after a long winter. Personally, as the days get a little longer, I start thinking of places to go and projects to do — as I'm sure many of you can relate. Between seasons — I naturally think of change. As Heraclitus once said,



"change is the only constant in life" and our industry is uniquely focused on change, isn't it? From changes in value, to changes in highest and best use, or changes in preferences/technology which impact the utility of real property. In the broad sense, we observe, measure and report on change daily.

At the Region III Q1 Meeting in San Antonio, TX - AI announced that our national website is being overhauled with an expected roll-out of early 4Q. You can stay current with happenings at AI-national by visiting appraisalinstitute.org/news/

Sharon Harbin (past president), Pete Arbour (vice president) and I will be in Washington DC from May 17-19, sharing ideas with and learning from other chapter leaders across the country. We will also be lobbying our respective Representatives and Senators on issues directly affecting our industry and members. One issue we will be throwing our support behind is the re-introduced PAL Act, HR 2771(govtrack.us/congress/bills/118/hr2771)

This proposed Amendment has bi-partisan support and will ease regulatory burdens on appraisers by creating a new mechanism for completing or processing appraisal license applications by authorizing the Appraisal Subcommittee to work with state appraiser regulatory agencies to create a central portal for appraisers to submit and manage their state license and certification applications/renewals through. This tool is envisioned to streamline tedious application processes facing many appraisers today such as the completion of background checks and submission of education records.

Locally, we are working through some of the technical obstacles to updating our website and getting a consolidated social media presence established and there will be more to come on that front in subsequent newsletters.

I hope to see you at a Chapter event — just a reminder that we have live USPAP and MI Law courses on Thursday, May 11, and our West MI Economic Summit on Friday, May 12, (along with our next Chapter meeting) in Grand Rapids. Dr. Paul Isley will update members on the state of the West Michigan economy and local commercial and residential brokers will provide emerging trends and observations from their respective spheres of practice.

#### **FHA Publishes Updates**

On January 18, the Federal Housing Administration (FHA) published its latest version of the Single Family Housing Policy Handbook 4000.1 (Handbook 4000.1). This update includes enhancements and revisions to existing guidelines and various technical edits. In many cases, this newly added language augments and enhances existing policy. The updates also consider feedback received from industry stakeholders. Update 13 includes language to clarify instruction, adds new guidance and information in Sections I, II, III, and IV and Appendix 3.0., and incorporates previously published Mortgagee Letters (MLs). Handbook 4000.1 updates are effective as follows

- The Handbook 4000.1 Transmittal reflects the addition of specific ML guidance, which is effective as previously announced in the corresponding ML.
- Changes identified in Section II.A of Handbook 4000.1 may be implemented immediately but must be implemented for mortgages with case numbers assigned on or after April 18, 2023.

All other changes may be implemented immediately but no later than April 18, 2023. Stakeholders are encouraged to review the changes outlined in the Handbook 4000.1 Transmittal. Additionally, a separate redline version of Handbook 4000.1 has been posted on the Handbook 4000.1 Information Page. The online version of Handbook 4000.1 is currently being updated and will be available soon.

## **Changes to Candidate for Designation Program**

Effective January 1, 2023, any education needed to earn an AI designation (a.k.a. designation education) will no longer be a component but instead a prerequisite to the Candidate for Designation program. As such, individuals seeking AI Designated membership who are not already Candidates for Designation must complete all required education to be eligible to enter the Candidate for Designation program. AI Admissions recommends that these individuals join AI as a Practicing Affiliate, complete all required education, then become a Candidate for Designation. appraisalinstitute.org/assets/1/7/ FYI Candidate for Designation Program.pdf
